For 22 years, the Dearborn Community Arts Council coordinated the annual Art on the Avenue Art Fair where exhibitors displayed their art outside on the streets in the heart of Dearborn's historic business/residential district.

**Now this popular tradition will move indoors to the centrally located, spectacular Ford Community Performing Arts Center.**

**FCPAC is considered one of the premier cultural/recreational facilities in the Midwest** and DCAC is proud to facilitate the 23<sup>rd</sup> year of the annual Art Fair at the Center with a fresh, energized multi-event weekend designed to appeal to all age groups.

Working with the City of Dearborn, attendees will have several scheduled activities that will coincide with the ART FAIR including continuous entertainment, specialty food options, Padzieski Art Gallery and Art in Public Places exhibitions, a Business Expo, children's activities, a healthy living jog/run.

### **Art Fair Exhibition times:**

Friday October 2- 4 pm to 8 pm - Preview

Saturday October 3- 10 am to 6 pm

Sunday October 4- 10 am to 6 pm

**Set-up time: Friday, Oct. 2 - 11 am to 3:30 pm**

-Applicants agree to comply with designated set-up times.

-Artists sell directly to the public. Each artist is responsible for collection and reporting of 6% Michigan Sales Tax.

-Parking is reserved for artists in designated locations.

Artists are expected to comply with all Police & fire code regulations as required by Michigan State Law.

All artists who donate an item for this worthy fund raising activity will receive extensive advance publicity, program recognition & booth location preference.

### **How to Apply:**

Submit four slides or digital images total.

1. Three images should be of the individual works to be exhibited.
2. One image should show the booth set-up
3. Slides must be standard 35MM or 2" x 2" size.
4. Label each with applicant's name & denote the "top" & "front".
5. Include a description sheet indicating the slide/image number, media, title of the work, dimensions & materials used or processes depicted. Only work of the quality & type submitted may be exhibited.
6. Only submitting artist original work (no imported/mass produced items) are considered.

**The non-refundable jury fee is \$15.00.**

\*If your application is marked "invited" then you have been pre-juried and no jury fee is required.

**The booth fee is \$160.00 for a 9'x9' space** with one six foot table.

-Only accepted exhibitors may occupy assigned booths.

Enclose separate checks with the completed application. If rejected, the booth fee will be returned with that notification & your slides/images. Include a self addressed, stamped envelope (SASE) with your application.

The artist is responsible for any & all returned check (NSF) fees.

### **Calendar:**

**Application deadline: June 20 (postmarked)**

Applications submitted after May 20 deadline must pay a \$25 non-refundable late fee in addition to jury and booth fees. You will be considered only if openings are still available in your specific media.

**DCAC Notification: Jury Committee decisions will be mailed by June 30.**

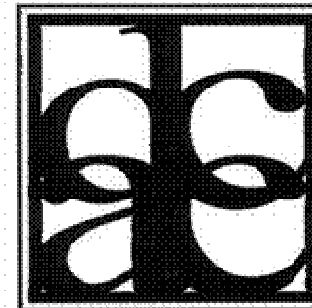
